Indigenous Assamese get land rights

PM Modi lands in poll-bound Assam amid anti-CAA, anti-NRC clamour

SIVASAGAR: Reaching out to the indigenous people of election-bound Assam amid frequent anti-CAA protests, Prime Minister Narendra Modi on Saturday distributed land ownership certificates to over 1 lakh such families, insisting the move will guarantee them "pride, freedom and protection".

On his first physical visit outside the national capital this year, Modi reaffirmed the state and the central government's commitment to protecting the land rights and the unique cultural traditions of the indigenous people.

He castigated the previous governments for depriving them of their land rights for years since Independence.

When the Sarbananda Sonowal government took over the reins in Assam, over 6 lakh indigenous families had no legal rights over their land. In the last few years over 2 lakh such families have
